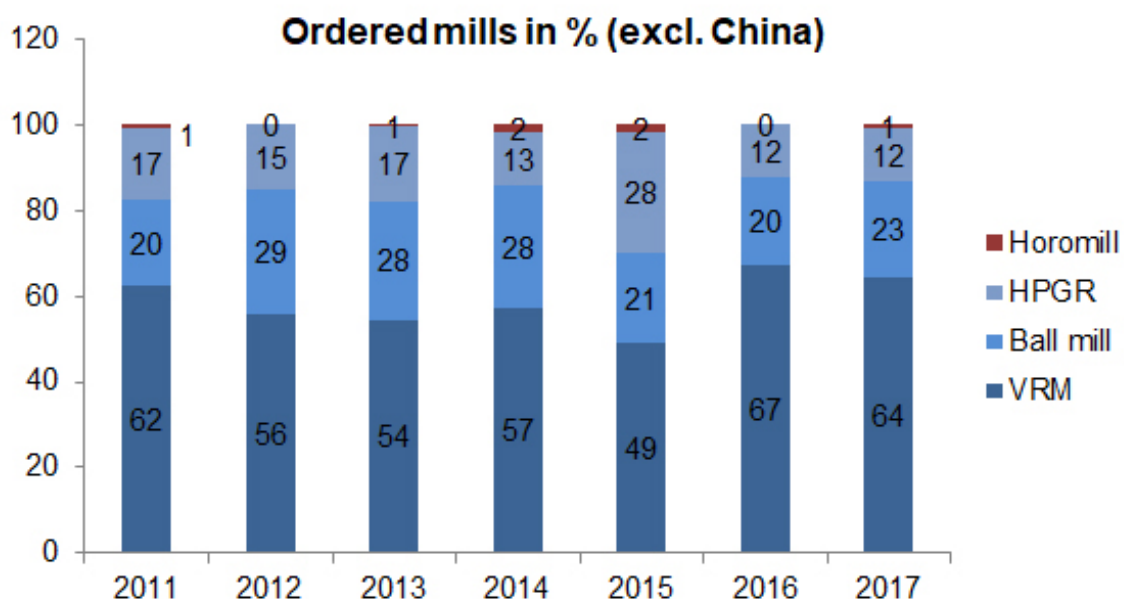
This brand new market report provides information about the buying behavior of the cement industry for grinding equipment. The market potential for grinding equipment is about 1.83 US\$bn, excl. China. From 2011 to 2017 a total of 1309 new mills were contracted outside China. In the same period 2854 mills were contracted in China. In this report the mill applications, type of mills, regions / countries and market shares of the suppliers are analysed in detail. The market report includes an outlook of the market potential by 2022.

### Report description

Methodology: The projects listed in the market report are mainly derived from the reference list and achievement records of the suppliers. In cases where information from company records was not comprehensive enough intensive research has been done to clarify the data. Interviews with market experts have been used to obtain and verify the information, and to access future market development. The quality of crosschecking of data in our primary research is, to the best of our knowledge, unparalleled worldwide.

The “Cement Industry Grinding 2022” market report analyses in detail the mill projects over the last 7 years for 9 world areas (W.-Europe, E.-Europe / CIS, Middle East, Central Asia, South Asia, Far East, Africa / Oceania, North America and Latin America) by order year, region/country, type of mill and application. China is separately covered in the report.

For whom is the report intended? This market report is intended for market-informed decision making. This will be especially useful for cement grinding equipment suppliers worldwide, who need to know what mills have been contracted since 2009 and how the market shares of suppliers have developed.
